

GLENMO AND GOLF SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. ALCOHOL IS NOT A PART OF ANY PRIZE.

The Glenmo and Golf Sweepstakes ("Sweepstakes") is sponsored by Moët Hennessy, USA Inc., ("Sponsor"), 85 Tenth Avenue, New York, NY 10011, and is administered by an independent third party ("Administrator").

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on April 1, 2019 at 12:00 PM Eastern Time ("ET") and ends on June 30, 2019 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal U.S. residents of the fifty (50) United States and the District of Columbia (not including residents of Utah, Puerto Rico, all U.S. territories and Possessions and overseas Military Installations), who are at least twenty-one (21) years old at the time of entry. Employees, directors, officers, and agents of Sponsor, Administrator, and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, advertising and promotional agencies and suppliers involved in the Sweepstakes ("Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. Employees, agents and officers of alcohol beverage retailers and distributors and their immediate family members and all other individuals/entities associated with this Sweepstakes are not eligible to enter or win. Void in Utah, Puerto Rico, all U.S. territories and Possessions and overseas Military Installations and where prohibited or restricted by law.

Participation constitutes Entrant's (as defined below) full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant ("Entrant") may visit <https://Glenmogolf.com> ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an Entrant will receive one (1) entry into the Sweepstakes.

Entry Limit: There is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an Entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that Entrant, in Sponsor's sole discretion, may not be eligible to win a prize. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on April 1, 2019 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. NOT ALL MOBILE TELEPHONE/WIRELESS PROVIDERS CARRY THE SERVICE NECESSARY TO PARTICIPATE IN THESE SWEEPSTAKES. ENTRANTS SHOULD CONSULT THEIR WIRELESS PROVIDER'S PRICING PLANS. 4. **RANDOM DRAWING:** On or around July 1, 2019, the Administrator will randomly select one (1) potential grand prize winner, five (5) potential first prize winners, and one hundred twenty (120) potential second prize winners from all eligible entries received during the Sweepstakes Period (upon successful completion of all required forms set forth herein, each potential winner to become a "Winner", and collectively the "Winners") Each Winner is considered a potential Winner pending verification of his/her eligibility and compliance with these Official Rules.

5. **PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

A. **Grand Prize (1):** The grand prize Winner will receive a trip for two (2) to Inverness, Scotland ("Grand Prize"). Trip includes round-trip coach class air transportation from a major commercial airport near Winner's residence to Inverness, Scotland for Winner and one (1) adult guest (age twenty-one [21] or older), four (4) nights hotel standard accommodations (single room/double occupancy), transportation to and from hotel and airport, an eighteen (18) hole round of golf at the Royal Dornoch golf course for Winner and guest, a tour of the Glenmorangie Distillery for Winner and guest, and a \$1,000 check (for Winner only). Winner's guests must be twenty-one (21) years of age or older. If the Winner elects to travel or partake in the Grand Prize without a guest, no additional compensation will be awarded to the Winner. Trip must be taken by December 31, 2020 or Grand Prize will be forfeited. Winner and guest must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the Grand Prize will not be awarded. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. Winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in this Grand Prize. Travel must be booked at least seven (7) days in advance. Guest of Winner must sign and return a travel liability release before travel will be booked. Winner and his or her guest hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the trip. Winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the Winner. Sponsor bears no responsibility if any event, element or detail of the Grand Prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of the Grand Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the prize, minus any unavailable event, element or detail. Only one (1) Grand Prize is available in the Sweepstakes. The approximate retail value ("ARV") of the Grand Prize is \$8,145.

B. **First Prizes (5):** Each first prize Winner will receive a Glenmorangie branded golf bag (each a "First Prize"). No more than Five (5) First Prizes are available in the Sweepstakes. The ARV of each First Prize is \$220.

C. **Second Prizes (120):** Each second prize Winner will receive a Glenmorangie polo shirt and twelve (12) branded golf balls (size of shirt determined by Sponsor in its sole discretion) (each a "Second Prize"). No more than one hundred twenty (120) Second Prizes are available in the Sweepstakes. The ARV of each Second Prize is \$37.34.

- D. Total ARV of All Prizes:** The total ARV of all Prizes is: \$13,725.80.
- E. Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
- F. General Conditions:** In no event will more one (1) Grand Prize, five (5) First Prizes, and one hundred twenty (120) Second Prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. Limit: One (1) prize per person.
- 6. HOW TO CLAIM A PRIZE:** The potential Winners are subject to verification of eligibility and compliance with these Official Rules After the random drawing, Administrator will notify the potential Winners via e-mail at the e-mail address provided at the time of registration. The potential Grand Prize Winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Grand Prize may be forfeited in its entirety and awarded to an alternate Winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a Winner's right to claim his/her prize, and may result in the prize being awarded to an alternate Winner, if time permits. Upon verification of eligibility, the Grand Prize Winner will be contacted to make arrangements for the Grand Prize and each First Prize and Second Prize will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of entry. Any portion of a prize not accepted by Winner will be forfeited. Each Winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. Sponsor will issue an IRS Form 1099-MISC for the Grand Prize Winner. All other costs and expenses not expressly set forth herein shall be solely each Winner's responsibility. The prizes will only be awarded to a verified Winner.

Sponsor will attempt to notify the potential Winners as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a Winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including the Winner notification e-mail, to a spam or junk folder. A prize that is unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason.

hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to Entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a Winner in a manner it deems fair and reasonable, including the selection of a Winner from among eligible entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more Winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the Winner.

ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN NEW YORK COUNTY, NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH**

RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
